Information regarding the use of methanol-containing bottles for sampling of solids

For the sampling of solid samples to be analyzed for BTEX, chlorinated compounds or other volatile organic compounds according to ISO 22155 (or HLUK Band 7 Teil 4) glass bottles containing methanol and an internal standard are provided by the AGROLAB Laboratories.

Before being shipped, the methanol-containing bottles are weighed and the resulting weight is documented on the bottle label. This weight is then used for the calculation of the concentration of the measured components once the sample is analyzed. The bottle label also contains the date the bottle was prepared as well as the lot number of the methanol used. This information ensures an unambiguous assignment of the corresponding blank value.

In the context of trace compounds analyses, the following aspects must be observed:

- Request the required number of sampling bottles some working days ahead, before the sampling campaign must take place. After reception of the request, the processing time in the laboratory is 2-3 working days, except by requests of 50 or more bottles, which need a longer processing time.
- Sampling bottles are to be used **within 60 days** after preparation (please note the preparation date on the label). The bottles are to be stored at 4 – 6°C. It is also required to ensure that the bottles are carefully closed and leak-free.
- During the sample taking the bottles should remain open the shortest time possible.
- After the sample taking and before closing the bottle, make sure that the rim is clean (wipe if needed), in order to **prevent leakages**.
- The sample quantity should be **around 25 g** (about 2 tablespoons).
- In principle, only so much sample material may be filled into the bottle so that it is still **completely covered with methanol**.
- **If no methanol-containing bottle is supplied to the laboratory for the analyses of volatile compounds, this must be documented on the report by means of a disclaimer.**
